But I did a lot of training on domestic violence and sexual violence, and for the most part, you know this, the fact that women lie about it is really a myth. Because up until very recently, women were not believed, I mean, and women were also blamed. Oh, you know, it's because you wore a short skirt, or you wore too much makeup, or your heels were too high. When do we know that none of that is true, that sexual assault is nothing, really, nothing to do with sex. It has to do with power and aggression, and it's not, I mean, it's not a sexual act, and, so when we had, when MeToo came out, you know, it was like, believe the women, and I still subscribe to that. I mean, there, like every rule, there are exceptions, and so I think you have to let the legal process play out. And you know, with the jury

And one of the things we used to talk about in the clinic is, why does the victim have to leave? I mean, why doesn't the abuser leave? I mean, it's just it's a very complicated issue.
